**Meeting Minutes**

- The meeting was called to order at 7:06pm.
- All Board Members were in attendance.
- Mission Statement was read.

  - Motion to accept minutes made Ashley Kamora and seconded by Jenn Scutt.
- Treasurer's report was read as follows:
  - **Beginning Balance:** \$ 32,766.17
    - **6 Deposit:** \$ 13,080.00
  - **Ending Balance:** \$ 45,846.17
  - Motion to accept treasurer's report was made by Dale Gilmore and seconded by Ashley Kamora.
- Fundraising:
  - We are looking for baskets for parent's night out.
  - Dick's sponsorship paperwork submitted
  - Nina's fundraiser will be at home games. They will donate 4 trays of pizza and wings at a discounted price.
  - Donation letters for purse bingo have been mailed.
- Football:
  - Sign-ups went well.
  - Looking into prices for new uniforms – pants and jerseys from Battaglia's this weekend.
  - Coaches meeting with Coach Dolhon set for 3/19, 5pm at the high school.
  - Paul working on the football constitution. This will layout league rules, code of conduct, I play time, etc.
  - ACC meeting proposals:
    - 9 week season passed, still need to determine beginning or end
    - 2 divisions passed
    - Executive board members can be from any organization passed
    - Beginning conditioning a week early did not pass
    - Doing away with waivers did not pass
    - NP proposal requiring scoreboard and timeclock required at playoff games passed
  - This season there will be 3 referees per game instead of 4
  - A motion was made to purchase water bottles with caddies, and an equipment wagon. Not to exceed \$150. Seconded by Amy and Moriah. Passed unanimously.
  - A motion to purchase 25 shoulder pads at \$125 each. Seconded by Ashley and Tara. Passed unanimously.
- Cheerleading:
  - We will use the Misericordia judges for competition.
  - There will be a coaches clinic June 24 or July 8.
  - ACC bylaws:
    - A \$250 fine will be charged if a team cheer coordinator does not fulfill their duties laid out by the ACC. Where the fine will be applied to be discussed with the full ACC board.
  - At competition there will be 3 judges plus 1 safety judge.
  - There will be a 10 point deduction for any coaching from the sidelines.
  - Hello cheer will award ribbons for first, second, and third place.

- Routine will be awarded banners for first, second, and third place.
- Motion made to purchase poms for each squad with carrying bags. Seconded by Melissa and Rose. Passed unanimously.
- Vice President:
  - New player sign-up date March 17 has been approved by the school
